## **Jumping**

- A) Athletes and Horses that participated in the 2011 FEI European Championship for Young Riders and Juniors in their respective age category are qualified to compete.
- B) Athletes (of the appropriate age) and Horses that have completed the first round of a Grand Prix competition at any 2011 or 2012 European CSI1\*/CSI2\* outdoor event or CSIO1\*/CSIO2\* outdoor event with a score of not more than eight penalties are qualified to compete.
- C) Athletes (of the appropriate age) and Horses that have completed the first round of a Grand Prix competition at any European CSI3\*, CSI4\* or CSI5\* outdoor event or the first round of a Nations Cup or Grand Prix competition at any CSIO3\*, CSIO4\* or CSIO5\* event with a score of not more than eight penalties are qualified to compete.
- D) Athletes and Horses that have completed the first round of a Grand Prix competition in their own Category at a CSIY/CSIJ outdoor event with a score of not more than eight penalties are qualified to compete.
- E) Athletes and Horses that have completed the first or second round of a Nations Cup competition in their own category at any CSIOY/CSIOJ outdoor event with a score of not more than eight penalties, or that have completed the first round of the Grand Prix competition in their own category with a score of not more than eight penalties, are qualified to compete.
- F) In addition, Athletes or Horses that have completed the first round of the Final of the Middle Tour (135cm; 238.2.2) during CSI2\* Wolborz, Boguslawice (POL) 27<sup>th</sup> 29<sup>th</sup> April 2012 with no more than eight penalties are qualified to compete.
- G) In addition, Athletes or Horses that have completed the first round with no more than eight penalties at either:
  - a. Competition No: 148 Gold Tour 1.35m (Week 3 03-08.04.2012)
  - b. Competition No: 171 Gold Tour 1.35m (Week 4 10-15.04.2012)

at the CSI3\* Arezzo – Toscana Tour (ITA) are qualified to compete.

- H) In addition, Athletes or Horses that have completed the first round with no more than eight penalties at either:
  - a. Competition No. 8 for Young Riders
  - b. Competition No. 9 for Junior Riders

at the CSIO4\* Copenhagen (DEN) 17-20.05.2012 are qualified to compete.

Timeline for athletes and horses to achieve the FEI minimum eligibility criteria is from the 1<sup>st</sup>

January 2011 through to the 13<sup>th</sup> July 2012.
